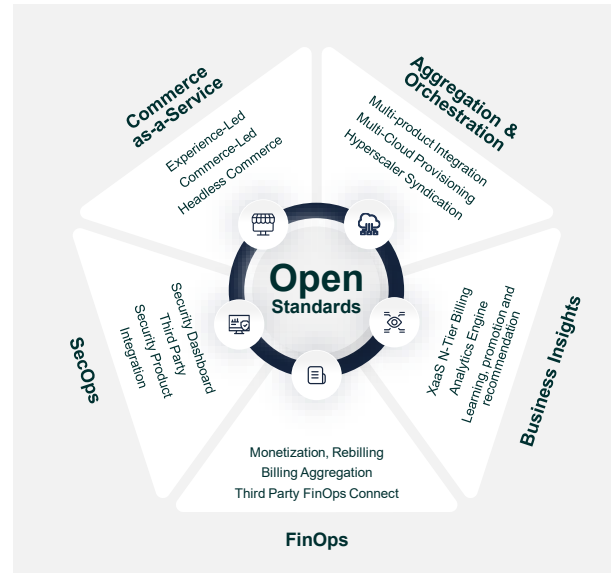

**ISV Syndication** enables partners to transact via Hyperscaler Marketplaces, accelerating product onboarding and offering private deals with streamlined lifecycle management. These updates reduce manual effort, enhance transactional accuracy, and unlock new revenue opportunities for partners through improved automation and marketplace integration.

#### Cancellation of Reseller Tenant-Acronis

StreamOne® Ion now enables resellers to manage Acronis subscription cancellations with greater flexibility. Tenant cancellations can be scheduled based on subscription end dates, with logic varying depending on timing. Mistaken cancellations are reversible, and canceled subscriptions may be reactivated within 14 days after expiry; recovery isn't possible beyond that window.

#### Azure Reserved Instances Billing Logic Update

StreamOne® Ion has updated its internal billing logic for Azure Reserved Instances to align with Microsoft's pricing model. Charges now follow a consistent monthly calculation using current exchange rates, improving accuracy. Manual adjustments by country teams are no longer needed, reducing operational overhead.

#### V3 Order API Enhancements

StreamOne® Ion has expanded its V3 Order API to enable access to data from parent accounts at the country level to reseller end customer information. This change provides transactional insights at global, regional, and country levels for sales, operations, and finance teams. The update will support tools such as the Executive Dashboard, PPC Dashboard, and Power BI reporting by offering product-level order data.
