



Google Cloud Platform - Billing calculations & pricing management enhancement

StreamOne® Ion now improves billing accuracy and pricing management for Google Cloud Platform by introducing a new “3rd Party Software” category in the GCP Pricebook. This enhancement ensures correct identification of SKUs without reseller margin and simplifies price adjustments, enabling better transparency, streamlined operations, and improved control over pricing strategies for partners.

AWS - Exclude Discounts for Non-Eligible Services

StreamOne® Ion now ensures greater billing accuracy for AWS by automatically excluding distributor discounts from non-eligible services. This backend-driven enhancement validates SKUs against an authorized list, applies pass-through rules where necessary, and automates APN fee credit handling.

AWS - Pass Through Pricebook enhancements

We've expanded its V3 Order API to enable access to data from parent accounts at the country level to reseller and customer information. This change provides transactional insights at global, regional, and country levels for sales, operations, and finance teams. The update will support tools such as the Executive Dashboard, PPC Dashboard, and Power BI reporting by offering product-level order data.
